- Support talented individuals resident in North Axholme who are able to demonstrate excellence in sport/art or culture, supported by independent evidence, e.g. selection to a recognised governing body national sports squad, working with professional artists, practitioner in a residence, mentoring or master class setting.
- ✓ Support participation of local community in activities not available in the local community
- ✓ Provide grants up to a maximum of £300
- ✓ Enhance quality of life for local residents
- ✓ Contribute to vibrant, healthy, successful and sustainable communities
- ✓ Promote community spirit and encourage community activity
- Retain all application to be submitted with the Micro Fund Monitoring Fund
- ✓ Aim to spend down the micro grant allowance each year.

Don'ts



- × Provide support to a constituted group
- Provide support for a project that is already receiving SSE Funding
- Provide support for applications which should be funded by statutory funding or Parish Precept
- × Retain funding for unforeseen applications.
- × Provide an award greater than £300
- Provide support to any activities that is not benefitting the community
- Support activities contrary to the interests of the SSE group of companies
- Support activities likely to bring the council, the company, or any member of the SSE group of companies into disrepute (for example anti-wind farm/renewable energy activities)
- Projects being delivered outside of North Axholme (including trips/excursions)
